INDEPENDENT AUDITOR'S REPORT

We have examined the accompanying schedules of deferred outflows for contributions subsequent to the June 30, 2015, measurement date by employer of the Florida Retirement System Pension Plan defined benefit plan and the Retiree Health Insurance Subsidy Program defined benefit plan, collectively referred to as the System Pension Plans, as of and for the fiscal year ended June 30, 2016. System Pension Plans management is responsible for the schedules of deferred outflows for contributions subsequent to the June 30, 2015, measurement date by employer. Our responsibility is to express an opinion on the schedules based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Accordingly, our examination included examining, on a test basis, evidence supporting the schedules of deferred outflows for contributions subsequent to the June 30, 2015, measurement date by employer, and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

In our opinion, the schedules referred to above present, in all material respects, the deferred outflows for contributions subsequent to the June 30, 2015, measurement date by employer based on criteria referred to in the management representation letter dated August 31, 2016.

In accordance with *Government Auditing Standards*, we are required to report all deficiencies that are considered to be significant deficiencies or material weaknesses¹ in internal control; fraud and noncompliance with provisions of laws or regulations that have a material effect on the schedules; any other instances that warrant the attention of those charged with governance; and abuse that has a material effect on the subject matter. We performed our examination to express an opinion on the schedules and not for the purpose of expressing an opinion on the System Pension Plans

¹ A material weakness is a deficiency, or combination of deficiencies, in internal control such that there is a reasonable possibility that material noncompliance will not be prevented, or detected and corrected on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

internal control or on compliance and other matters; accordingly, we express no such opinions. Because of its limited purpose, our examination would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses. Given these limitations, during our examination we did not identify any deficiencies that we considered to be material weaknesses. However, material weaknesses may exist that have not been identified. In addition, our examination disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

This report is intended solely for the information and use of System Pension Plans management, employers participating in the System Pension Plans and their auditors and is not intended to be and should not be used by anyone other than these specified parties. However, pursuant to Section 11.45(4)(c), Florida Statutes, this report is a public record and its distribution is not limited.
